

## The Interaction of Functional Morphemes inside the Nominal Phrase


This book explores the limits and possibilities of morpheme ordering in the noun phrase. Based on a sample of fifty geographically and genetically diverse languages, it presents the attested and unattested combinations of case, number, and definiteness morphemes. The account covers not only languages with agglutinative morphology but also languages that fuse more grammatical categories into a single morphological exponent a portmanteau. The book shows that not all patterns of morpheme ordering that are logically possible are equally represented within the sample and, importantly, certain patterns are not attested at all. The book provides an account for this observation by using the latest theoretical tools from the nanosyntactic framework, namely spellout-driven movement, backtracking, and Spec formation. The results of this study provide evidence for the hypothesis that ordering in morphology is governed by the same principles as in syntax.

## Aspects of the grammar of names

Empirical case studies and theoretical topics

The articles of this volume contribute to the research of the grammar of names, a newly established and constantly growing linguistic field. Concentrating on two onymic categories, viz. person names (anthroponyms) and place names (toponyms), the five studies give insights into several aspects of the grammar of names, e.g. the position of onyms in the grammar system of a given language, morphosyntactic distinctive features of names, or the use of articles with onyms. The empirical evidence (synchronic as well as diachronic language data) for these studies comes primarily from Austronesian, Siouan, and Romance languages. Two in-depth studies on anthroponyms in a Siouan language spoken in North America and toponyms in an Austronesian language of Micronesia, respectively, are framed by comparative and typological surveys. By providing insight into the grammar of names both of individual languages and from a typological perspective, it is shown that onyms do not always share the same features as common nouns, although they are often treated as a subcategory of these. This volume thus contributes to the discussion on whether onyms can be subsumed under the same notion as common nouns or rather comprise a category on their own.




Lingála is a Bantu language with a total of approximately 45 million native speakers and lingua franca users. It is spoken in the west and north DR Congo (including in Kinshasa), in the Republic of Congo (including in Brazzaville), and in northwest Angola. It also continues to strengthen its position as a secondary lingua franca in parts of the DRC where Kikongo, Swahili, and Tshiluba are the dominant lingua francas. In addition, it is the main medium of communication and emblem of Congolese identity among the Central African diaspora. Lingála's origins go back to the pidginization of Bobangi in the 1880s, an episode to which it still owes a reduced system of noun class agreement as well as grammatical and lexical generalizations. This second, revised and enlarged edition offers thoroughly updated discussions of items already treated in the first edition (*A Grammatical Overview of Lingála*, Lincom Studies in African Linguistics 81, 2010), and especially adds new analyses of many structures that were not yet covered. It also offers much more examples, many of which were culled from corpora, to illustrate the grammatical features and analyses. The account of the sociohistorical background of Lingála has also been revised and amply extended on the basis of newly discovered sources.

The present volume is a collection of papers presented in various national and international seminars from 1980's to 2019. The papers cover all genres of narrative namely tale, legend and myth; in addition to that, papers on episodes from the great Indian Ithihas, Ramayana and Mahabharata, have been included. Researches on folktales and mythology from other cultures and languages have been published in general, in abundance, and some on Tamil folktales and mythology by great authors have appeared on the international arena.

All three genres are related, in the sense they are narratives, and not related, in the sense they have their own characteristics. As the humour in Tamil folktales is unique, and the story telling techniques are intelligent, the characters in the tales are down to earth, the concepts found in Tamil myths are very ancient, some of the interesting tales, myths and legends were chosen by the author to introduce them to the non-Tamil world and scholars.

The two great Ithihas of India are well known to the world in general; but the episodes with indigenous and ingenious ideas of Tamil people are to be known to the world. Hence they have been included in the collection. It is hoped that the present volume would be appreciated by the non-Tamil readers and scholars of Folklore and mythology, especially folk narrative research would find it useful.

Als ich anfangs 1928 von Bahia (Nordbrasilien), wo ich seit 1924 an der dortigen philosophisch-theologischen Fakultät der deutschen Franziskaner einen Lehrauftrag für Philosophie hatte, eine seit langem vorbereitete Forschungsreise zu den Mundurukú-Indianern antrat, hoffte ich, viele und wertvolle Ergebnisse für Linguistik und Ethnologie heimbringen zu dürfen. ## Languages of the World/Materials

### A Grammar of Thakali

This grammar explores sensory motor-codes (viz., phonological) and grammatical codes in Thakali within adaptive approach and compares them with those in other West Bodish languages from typological perspective. Besides, it shades light on the empirical adequacy of the approach.

Thakali employs segmental phonology including tones to code 'words' at conceptual lexicon and morphology, intonation and word order as morpho-syntactic devices to code atomic proposition and discourse. As a Bodish language, Thakali shares most of the coding devices with other West Bodish languages. Except tone, Thakali shares the phonological features with Chantyal. In number marking, Thakali is very close to Ghale, Magar Kaire and Western Tamang. Both Gurung and Thakali shares benefactive marking.

There is almost the same pattern of inclusivity marking in Thakali, Gurung and Nar-Phu. Honorificity is displayed in Tamang, Nar-Phu and Thakali. In interrogative marking, Thakali, Nar-Phu and Chantyal share many features. Thakali shares many features of the complex constructions with other Bodish languages. However, it remarkably differs from other West-Bodish languages in terms of some language specific coding devices governed by the factors: cultural, developmental and communicative. In terms of egophoricity and marking dependent (viz., modifiers) in the noun phrase Thakali stands distinct from other members of West Bodish. The structural tendencies (viz., rules) so far explored in Thakali are in congruent with the empirical adequacies: descriptive, pragmatic, cognitive, typological and explanatory as proposed in the adaptive approach to grammatical analysis.

La lecture de cet ouvrage dévoile les différents messages véhiculés par ces signes linguistiques et permet de comprendre que ces noms luba-kasayi, à leur origine, n'ont pas été des fruits du hasard! Étant donné que tout phénomène de la nature a toujours une cause en amont de son existence, on se rendra à l'évidence que le nom propre en Buluba est la résultante d'un acte motivé qui trouve sa justification dans la conception du nom lui-même qui, chez les Baluba du Kasayi, est une marque ou signe particulier d'identité, linguistiquement doté d'un sens caché, qui est issu de la motivation socio-sémantique cachée, qui est elle-même reprise dans la synthèse que constitue le nom apparent.

### I composti bahuvrīhi delle antiche lingue germaniche

Analisi morfologica e semantica

L'obiettivo di questo volume è lo studio morfologico e semantico del composto bahuvrīhi nelle antiche lingue germaniche orientali e occidentali, impiegando un approccio cognitivo. Questo framework aiuta a comprendere sia i meccanismi che rendono possibile la costruzione di tale composto, sia i meccanismi che contribuiscono alla creazione del suo significato. Per fare questo, dopo aver

discusso circa il valore dell'endocentricità ed esocentricità in composizione, ci si focalizza sui composti bahuvrīhi in gotico, antico alto tedesco, antico sassone, antico frisone e anglosassone che presentano una struttura morfologica [A+N], [N+N] e [Num+N].

Lo spoglio delle fonti ha consentito di raggruppare 587 bahuvrīhi. A differenza delle lingue germaniche moderne in cui compaiono solo bahuvrīhi nominali, in passato questo composto era prevalentemente aggettivale e ne esistevano tre tipi: il lineare, l'esteso e il tipo invertito.

Oltre a descrizioni più formali delle strutture morfologiche che concorrono alla formazione dei bahuvrīhi in queste lingue, si sono utilizzati anche modelli di rappresentazione morfologica propri della linguistica cognitiva. Viene data attenzione anche all'aspetto semantico, in particolare al motivo per cui molti dei bahuvrīhi delle lingue germaniche antiche possiedono una certa opacità semantica. La teoria della metafora e della metonimia concettuali spiegano la ragione di tali "devianze" semantiche.

### The Linguistic Identities of the Milky Shaikhs in India: A Myth or Reality

This book deals with the speech of the Milky Shaikh community in Bihar, India. The Milky Shaikhs perceive their language "Milky" to have roots in Persian and Arabic, and have affinity with Urdu. The Milky Shaikhs coexists with the Bhojpuri speaking community, the dominant language of the region, where the present study was conducted. However, the linguistic analysis of Milky shows it to be more like a contact language with features of both Urdu and Bhojpuri. The linguistic structure of Milky is closer to Bhojpuri than Urdu. Urdu indexes Muslim identity in North and Central India. Urdu is used in Islamic texts and teaching in Islamic seminaries. It also has a very rich literary tradition. In the recent years, the use of Urdu is declining in the younger generation of the Muslim community. But Urdu is still part of the collective memory and cultural, and religious identity of the Muslims in North

and Central India. The Milky Shaikhs, who are also Muslims identify themselves with the rich heritage of Urdu. They assume their language to be in proximity with Urdu, which is however not the case. Thus, this study shows how ideology and socio-political history construct the 'linguistic identity' of the Milky Shaikh community.

### Texts of Niesu, a Southeastern Dialect of Nuosu: Analyzed Spontaneous Narratives and Grammatical Notes

This book is a collection of the spontaneous narratives in Niesu, an understudied member of the Ngwi (aka. Loloish) subgroup of the Burmic (aka. Burmese-Lolo or Burmese-Ngwi) language group of the Tibeto-Burman family (Bradley 1997, 2012). It is spoken by 662,922 people, who are officially recognized as Yi (彝族) (exonym) by the Han Chinese, residing in mountainous regions in Liangshan (literally 'Cool Mountains'), Sichuan, southwest China.

Niesu [nie33 su33] is the autonym of the Niesu Yi people, with two sense-bearing morphemes, namely nie33 'black' and su33 'people', which means 'black people'. Niesu is the southeastern dialect of Nuosu which is a relatively well-studied variety of Nuosu proper. The current book is the first collection of texts based on Adur Niesu, spoken in Butuo, central Liangshan.

### Variation in Japanese Word Formation

The Japanese language is phonologically moraic and morphologically agglutinative. It is unique, with (a) a transitive/unaccusative verb alternation system rendered by morpheme; (b) split intransitivity; and (c) split subjectivity that is displayed in all part of speech (suffixes and prefixes, adjectives, particles, auxiliaries, nouns, adnominals, adverbs and transitive/intransitive verb pairs). Word formation in Japanese is an issue of phonology, morphonology and semantics. This book is composed of 10 chapters, which address formation in phonology and morphonology (nominal compounding, Chapter 5); formation in morphosyntax (verb compounding, Chapter 3); formation in morphonology (derivation, Chapter 4); formation in syntax (middles, Chapter 6; split intransitivity, Chapter 8); and formation in semantics (split subjectivity, Chapter 7). Investigating word formation (particularly compounding and derivation) brings to light the interrelationship between grammaticalisation and lexicalisation: orthogonal.

### Las lenguas y los sentidos

La construcción del sonido en cuatro lenguas: mi<sup>?</sup>phaa, wixárika, alemán y castellano

Las lenguas y los sentidos es una investigación contrastiva y tipológica sobre el procesamiento lingüístico designado de cuatro dominios sensoriales (sound, smell, taste and color) en 4 lenguas, dos europeas (alemán y castellano) y dos americanas (wixárika y mi<sup>?</sup>phaa). Cada dominio es investigado en las 4 lenguas y en cada lengua se hace un estudio comparativo de los 4 dominios. Las 4 lenguas comparten una bási-

densidad de términos básicos en los dominios del color, olor y sabor, pero la comparación no se limita a los términos básicos, sino que se extiende a 13 técnicas que constituyen una operación lingüística; la mitad de ellas no forman términos léxicos, pero contribuyen de manera importante a la desigual estructuración de un discurso en los cuatro dominios y en las 4 lenguas.

Semántica y pragmática son las dos invariantes funcionales que actúan de manera complementaria en la operación. La actividad lingüística es un sistema dinámico movido tanto por reglas semánticas abstractas como por reglas pragmáticas que coarticulan el significado inherente con el conocimiento práctico y la situación comunicativa. En las técnicas léxicas, sobre todo en el etiquetado específico, prominente en wixárika, alemán y español en diferentes grados, prevalece el componente semántico, mientras que otras técnicas como el etiquetado genérico o la técnica resultativa se basan en procesos inferenciales que completan el significado a partir del contexto.

This grammatical sketch describes Chinyanja of Tanzania, a Bantu language (N201) spoken on the eastern shores of Lake Nyasa (also known as Lake Malawi) on the Tanzania-Mozambique border. This previously undescribed language belongs to a cluster of languages that includes Mang'anja and Chewa languages spoken in Mozambique and Malawi.

After introducing the language, the sketch discusses its affiliation. One chapter presents its phonology, and another covers the rich morphology of nouns, pronouns, and other nominal modifiers, as well as verbs. The syntax chapter describes grammatical relations, transitivity types, sentence types, and the structure of complex sentences. Included also is a description of discourse features in syntax. A narrative is provided as a sample text in the appendix.

## Diacronia e sincronia del complementatore *mi* in siciliano

Nel volume vengono presentati uno studio diacronico e una analisi sincronica del complementatore del siciliano nordorientale *mi*. Questa struttura ha ricevuto l'attenzione di molti studiosi, sia per la molteplicità di funzioni che mostra nelle varietà linguistiche in cui *mi* è impiegato (oltre a introdurre complete di vario tipo, può essere usato in frasi indipendenti per designare valori modali), sia per le ipotesi relative all'origine della struttura, che richiamano spesso l'apporto del sostrato greco.

Nella sezione diacronica, viene indagata l'origine del complementatore attraverso l'analisi dei testi di siciliano antico, con particolare riferimento alle occorrenze dell'avverbio *modu* da cui è stato rianalizzato il *mi* contemporaneo. Lo studio dei testi antichi permette di ricostruire il percorso di grammaticalizzazione della struttura, chiarendo il ruolo di alcune caratteristiche formali e semantiche delle occorrenze di *modu* nel processo di reinterpretazione funzionale della costruzione. Nel quadro storico, vengono, inoltre, indagati i passaggi riconducibili a un ulteriore processo di costruzionalizzazione, alla base del radicamento degli impieghi di *mi* in proposizioni indipendenti (ovvero gli impieghi in insubordinata) per designare valori modali deontici.

Nella sezione sincronica, vengono analizzati dati di prima mano ricavati da un corpus di interazioni spontanee. L'indagine mette in luce, primariamente, le proprietà strutturali e semantiche degli usi subordinanti di *mi* in siciliano nordorientale contemporaneo, mostrando i diversi gradi di incassamento delle proposizioni introdotte da *mi*, le restrizioni di selezione relative alla reggenza verbale, la posizione degli elementi nella clausola, i rapporti di coordinamento tra più proposizioni e i tempi selezionati nelle complete. L'ultima parte del lavoro è dedicata agli impieghi contemporanei di *mi* in insubordinata. L'analisi rivela che oggi il complementatore ha subito un ulteriore processo di reinterpretazione, che ha esteso l'impiego di *mi* alla designazione di valori modali epistemici.

## The Circulation of Social Energy in the Canterbury Tales

Stimulated by the aspiration to talk with the past, this book relocates the Canterbury Tales in its historical context to uncover the cultural, social, and economic traces suppressed and refigured in the process of literary representation. Chaucer assimilates his vision of the medieval social energy into a discursive construct that absorbs the diversity of late fourteenth-century reality. Under the umbrella of the festive pilgrimage, Chaucer makes room for the lower-class pilgrims to subvert the medieval weltanschauung and its theologically-grounded culture as bodied forth in the Boethianised and epicised Knight's Tale. However, the seditious seeds, grown in disruptive tales like the Miller's and Wife of Bath's, are infused with subtexts that undo and contain the subversive potential. The sense of containment receives further emphasis in the Clerk's Tale, the Parson's Tale, and the Retractions which, in their affirmation of the reigning orthodoxies, preach submission to all forms of authority (fatherly, husbandly, feudal, and divine).

*Anthology of Menominee Sayings* is the result of seven years of field work (conducted during the 1980's) with about half a dozen speakers of one of Wisconsin's indigenous Algonquian languages. The anthology, consisting of some 450 short pieces of Menominee oral tradition, contains weather rules, conventions and taboos surrounding hunting and fishing, wisdom on the conduct of life, and omens predicting good or ill. The texts, therefore, tell of the community's interest in the contour of life from its inception to its preservation and eventual demise. Each text is accompanied by an English translation and, where necessary, explanatory linguistic and cultural notes.

The notes take Bloomfield's grammatical description and lexicon of Menominee as a point of comparison, and indicate phonetic, phonological, morphological, syn-

tactic and semantic departures from the state of the language as described by him. The text is useful to students of culture, folklore, Native American studies, as well as historical and descriptive linguistics.

The volume concludes with a short descriptive grammar focusing on phonology, morphology and syntax.

### Salinan Language Studies

David Shaul

Salinan (coastal central California) is not only abundantly attested in modern recordings after 1900, but also is the only native California language to have been richly documented by the Franciscans in the 1800s. This work contains a summary of the sound pattern, and the most complete morphosyntax description of the language. Data is from both dialects (Antoniano, Migueleño), but is mostly Antoniano.

Of particular interest is the revelation of a pitch-accent system (two melodies), accounting for "stress" irregularity. The remarkable variety of plural forms is explained by a process of derivation that depends on the melody inherent in a given root. Pluractionality in verbs is shown to be rare, especially in data recorded after 1900. A specifier serves as only productive adposition, and also is used in marking relative clauses and in person possessor marking on nouns. The stative-active resolution of Salinan verbs is explored through occurrences of each category in texts. Sample texts, some never published, show the discourse strategy of Salinan. A summary is given of Salinan linguistic prehistory with application of Hokan Common Core. The *Salinan and English Lexicon* is a companion volume.

### Salinan and English Lexicon

This companion volume to *Salinan Language Studies* contains the lexical artifacts upon which the description in the companion volume is based. Based on the descriptive data on Salinan after 1900, it also includes the bountiful data of the vocabulary compiled in the late 1700s by the Franciscans Buenaventura Sitjar and Miguel Piers. Of the two dialects (Antoniano, Migueleño), Antoniano is the main data source (because of readily available data). However, Migueleño lexical artifacts are given where they are noted in the modern, non-audio recordings of the language. Main entry in the lexicon is by morpheme, and there are just over 2,100 main entries. The English-Salinan index refers the user to compounds and derivations listed under their root morphemes in the lexicon.
